- Q Why has there been a change to the gym club? Why is there now no charge?
 - A We are using Sports premium money as some children were unable to access the club but now can. The club is now

totally inclusive, which is part of the Gold standard, school games award.

14. School Improvement Plan

Governor Strategic plan

- Strategic plan was written when we were RI with a view to get to good, now we need to review it to get to outstanding
- Succession planning to be added. Headteacher to send out governance framework for governors to see what outstanding looks like and review how we can get there.

Priority 1

- Completed but matters are ongoing. Governors agree to keep this priority in SIP
- Individual Children's data was made available to parents during parent's evening.
 - Whole school data is not on website as we did not have enough children to report results, we will have this year though. A link will take parents to data dashboard. Headteacher to consider how to show information clearly. Also need to celebrate Ofsted report 'good Ofsted shows that we are getting the best out of what we have got'.
 - Governors are more visible governor termly letter from Mrs Middleton & governor on the gate have made parents more aware of governors who are now seen as part of the school; this has made the most impact in increasing parents understanding of governance. Governors to attend parents evening 31st October & 2nd November if available, to hand out new questionnaires
- Last parent questionnaire showed 100% of parents were now happy with communication
- Governor to attend parent forum. Scheme of delegation document could be used to education parents as to what governors do and use it as a discussion point.
